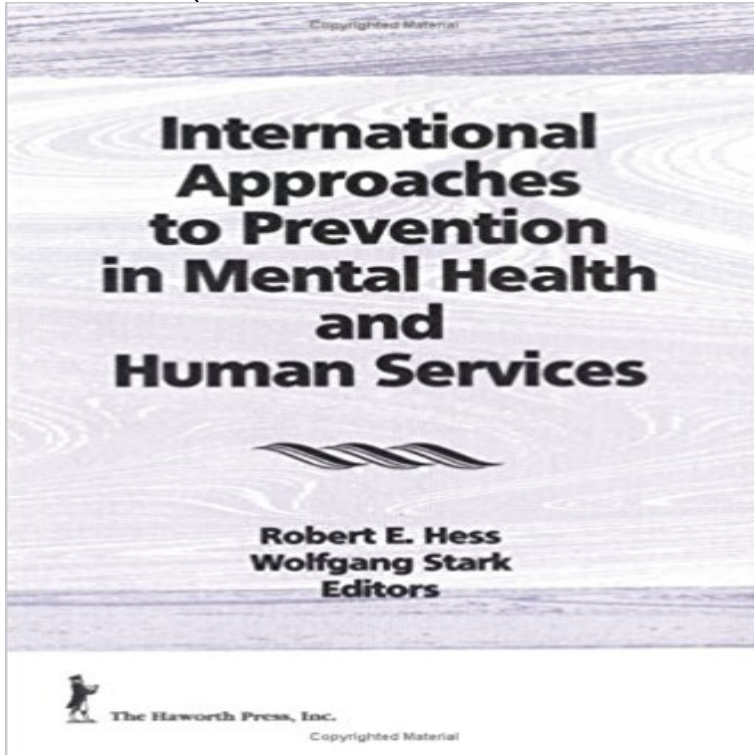


# International Approaches to Prevention in Mental Health and Human Services (Prevention in Human Services)
