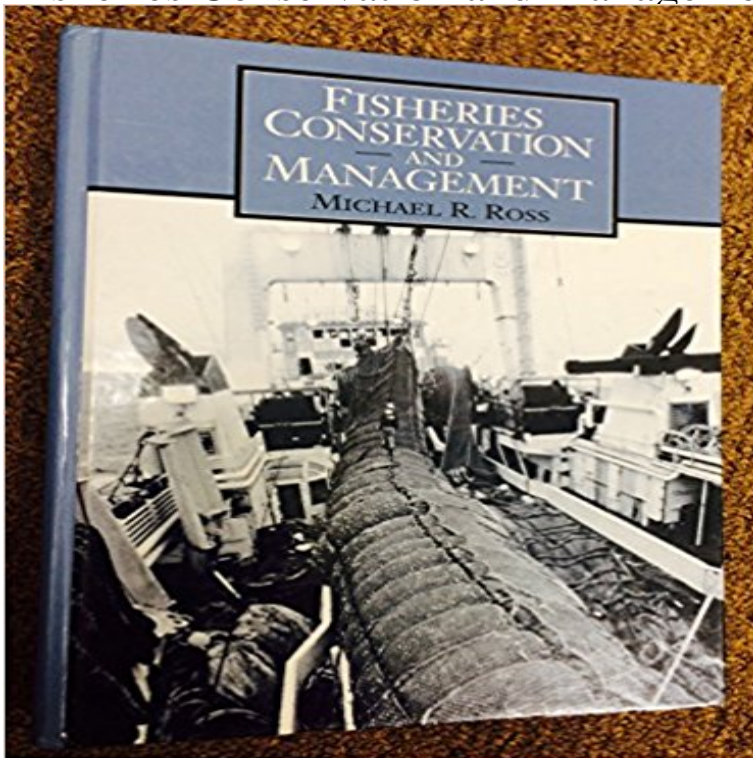


Fisheries Conservation and Management
